### **ADOPTION OF PREVIOUS MINUTES**

A motion was made by David Cope to approve the title change from Community Projects Director to Vice President of Community Health Programs, motion was seconded by Teresa Stephens. The Motion passed unanimously.



**Balanced Scorecard Update** – Debra Velez provided an update on the Balanced Scorecard and Strategy Map. Mrs. Velez also gave a brief tour of MCHD's new website.

**AdventHealth Lease** – Rusty Branson shared an update on the physical assets on the AdventHealth Lease. Rich Bianculli inquired if MCHD is maintaining inspections on AdventHealth facilities. Joe Hanratty confirmed inspections are being maintained.
