MCHD Bylaws -Joe Hanratty presented the revised MCHD Bylaws to reflect the addition of the last sentence in Section 6.11. Conflicts of Interest and Standards of Conduct. — "To avoid an appearance of a violation of 112313 (6), Fla. Stat (2019), as the same may hereafter be amended, Trustees shall not vote on matters that benefit entities that the Trustee is a board member, owner or employee".

A **Motion** was made by Sheryll Goedert to approve the amended bylaws as presented. The **Motion** was seconded by Sam McConnell. The **Motion** passed unanimously.

TimberRidge Nursing Home Quit Claim Deed and Non-Exclusive Easement - Win Porter is selling the nursing home and in preparing for the transaction it was determined that there was a scrivener error in the legal description of the prior conveyance omitting a 10' by 15' area of land. The quit claim deed addresses that issue. Additionally, the storm water retention pond for the nursing home is located on District property. Joe recommends that the District grant a non-exclusive easement for the pond. The owner of the nursing home will be required to maintain the retention area, and the District may relocate the pond in the future to accommodate development of the remaining District property. As a result of the transaction the District will be paid off from the mortgage that it holds on the property.

A **Motion** was made by Ken Marino to approve the TimberRidge Quit Claim Deed and Non-Exclusive Easement as presented. The **Motion** was seconded by Randy Klein. After some discussion, A **Motion** was made by Randy Klein to amend the Non-Exclusive Easement to state that TimberRidge cannot amend the SW District Permit without the District's consent. The **Motion** was seconded by Ken Marino. The **Motion** passed unanimously. Joe Hanratty will make the changes.

Hope Clinic is still having technical difficulties including timely communication with the District, improper completion of forms and not confirming to due dates or complying with the approved budget. Hope Clinic will not receive any further funds from the District. The Marion County Parks & Recreation Walking trail is completed and being used by the citizens.

Marion County Children's Alliance (MCCA) - The Children's Alliance presented another mental health project for the remainder of the 4th Grant Cycle called MCHD SADD (Student Against Destructive Decisions) Youth Prevention Grant. SADD's mission is to provide students with the best prevention tools possible to deal with the issues of underage drinking, other drug use, risky and impaired driving, and other destructive decisions. Originally, the mission of the SADD chapter was to help young people say "No" to drinking and driving.

A **Motion** was made by Randy Klein to approve the Children's Alliance new project as presented for the rest of this grant cycle utilizing the remaining of their revised \$40,200.59 grant funds. The **Motion** was seconded by Ram Vasudevan. The **Motion** passed unanimously with one recusal.
